Purpose of the PCTA Leadership Award

This annual award recognizes dynamic leaders who have contributed to the vision and leadership of the Physician Clinical Teachers' Association. The individual has provided outstanding service to the PCTA, advocating on behalf of the members to support their interests in clinical education, research, and innovation.

Eligibility

Physician Clinical Teachers at NOSM U, who are group physicians, and hold a current certificate of registration issued by the CPSO. PCTA Board Members are not eligible to be nominated for the award during their term of office.

Criteria of the PCTA Leader

- Demonstrated commitment to excellence and innovation in the leadership of the NOSM U physician clinical teachers.
- Has had a lasting impact on the physician clinical teacher's clinical education delivery model, clinical innovation, and the establishment of measurable outcomes to support physician clinical teachers.
- Promotes EDI
- Advocated on behalf of the members of OMA, NOSM U, and other relevant organizations.
- Evidence of effective peer leadership and mentorship ability in their roles.
- Embodies and integrates the values of professionalism, communicator, collaborator, manager, and advocate as evidenced in their achievements.
- Fair, effective, and collaborative leadership style.
- Demonstrated commitment to clinical practice, research, and teaching.

Nominations:

1. Call for Nominations will be sent to PCTA members.
2. Nominations can be submitted by PCTA members.
3. Each nomination must include two nominators.
4. We encourage all LEGs to nominate at least one member from their LEG or any other PCTA member who exemplifies the criteria of a PCTA Leader.
5. Physicians can be re-nominated in subsequent years; however, previous winners will not be eligible to win again.
6. Nominations are to be forwarded to the PCTA Board Award Committee at pcta@noama.ca by **February 23, 2026**.
7. Supplementary materials submitted with the nomination package will not be included in the adjudication process. While CVs are not required to be submitted with the nomination form, they may be included. If a CV is not provided at the time of submission, NOAMA will contact the nominee directly to obtain it as part of the standard review process.

Selection:

- 1) Applications for the award are adjudicated by a sub-committee appointed by the PCTA Executive Committee.
- 2) The award will be presented to the successful nominee at Northern Constellations.
